

# Report from *Ad Hoc* Committee on Membership Definition

## AD-HOC COMMITTEE - MEMBERSHIP

#### **COMMITTEE ACTIONS & RECOMMENDATIONS**

#### **OVERVIEW**

The Hockey Alberta Board set an objective to review the definition of membership that is currently within the Hockey Alberta Bylaws. An Ad-Hoc Committee was created, and Hockey Alberta went out to its membership to ask for interested candidates. It was very important to have the committee made up of Hockey Alberta members and engage the entire membership.

A Notice of Motion will be brought forward at the 2020 Hockey Alberta AGM or perhaps sooner at a Special Meeting of the Members. An outline of the committee work to date is below for reference.

#### **AD-HOC COMMITTEE WORK:**

The Ad-Hoc Committee participated in an environmental scan which included information about our existing membership structure, some of the gaps within it, as well as information on what other Provincial Sport Organizations and other Member Branches of Hockey Canada currently do within their membership bylaws.

The current bylaw leaves a number of stakeholders who represent registered participants without a formal voice/vote as a 'member'. The committee discussed each of these areas and related their discussions to what other organizations have chosen to do. The committee engaged a group of stakeholders to review, critique, and add to their work.

The committee discussed the differences between the need to be members per the bylaw and/or the need to have a stronger operational tie and voice within Hockey Alberta. The committee reviewed the following core elements of our game as it related to membership within Hockey Alberta as well as the importance of maintaining, and in many cases, improving operational connectivity.

#### Sledge Hockey Programs:

There are 6 programs within Alberta that are currently operating Sledge Hockey in Alberta. The players through these programs are registering with Hockey Alberta.

Recommendation of the Committee: There be provisions in the bylaws to allow Sledge Hockey Programs to be members.

#### Recreational (Pond) Hockey Programs:

There are currently 56 Pond Hockey Programs within the Hockey Alberta structure that are operating registered programs but are not members. In some cases, these programs are within the minor hockey association and act as a sub-committee. In other cases, the programs operate separate from the minor hockey association.

Recommendation of the committee: There be provisions in the bylaws to allow Recreational Hockey Programs, such as Pond Hockey, to be members.

#### Hockey Canada Accredited Schools (Sports Schools):

There are currently 5 programs within Alberta that operate and register players. They feature 19 total teams. These have evolved over time from having one program in the mid 1990's to the five we have currently. During this time, Hockey Canada has created regulation and policy on how these programs are formed and recognized. They do not have membership status currently. Currently there is a National review of the definition of Hockey Canada Accredited Schools. This will add further definition to what the programs need to be.

Recommendation of the committee: There be provisions in the bylaws to allow Accredited Schools to be members.

#### Junior / Senior Hockey Teams & Leagues:

Teams are currently registered with Hockey Alberta and are each a member on their own. Leagues in these levels of hockey act as extensions of Hockey Alberta to some extent as the Presidents are the representatives that sit on our operational committees. It was felt this system works well in the province and could be extended to allow teams to be formally represented to Hockey Alberta through their leagues.

Recommendation of the committee: That Junior A, Junior B, Junior C, and Senior Hockey Leagues become the members of Hockey Alberta representing the teams that are part of them.

#### Minor Hockey Leagues:

There are concerns with the alignment of leagues within the Hockey Alberta structure. The committee discussed this at length and in some of the concepts looked at providing the opportunity for leagues to be non-voting members. At the conclusion of the meetings, the committee arrived at the fact that minor leagues are an important stakeholder of the game. They are owned by the members. They are a key operational element of the game that needs to be better aligned with Hockey Alberta and its members. This alignment is a responsibility of Hockey Alberta, its members and the leagues.

Recommendation of the committee: That Minor Leagues are not to be members of Hockey Alberta.

#### Officials:

The committee talked at length about the manner in which Alberta's 5000+ officials have a voice within the system. Changes made to the Governance Model in 2011 removed specific representation from the Board and further changes in the last few seasons have aligned the Officials Committee under Hockey Alberta's operational model. The Officials in the game, and the volunteer roles that support them, are very important elements to the success of the game. Discussion continued regarding how the individual officials have a voice within Hockey Alberta and/or if that is needed.

Recommendation of the committee: That Officials are not to be members of Hockey Alberta. The committee simply could not find what they considered to be an appropriate opportunity to have representation of the 5000+ Officials as members while also continuing with the current operational model.

#### Streams of Hockey:

The committee took the chance to look at some traditional and some recent trends that have evolved. These programs, based on current bylaw, all fit within minor hockey associations. The committee felt that it was worthy to review the merits of considering these types of organizations as members. It is understood that in each of these cases the programs currently operate under the umbrella of a host minor hockey association. The operation of these programs is often quite different than the operation of the overall association. Programs include:

- Male ADM Programs in Midget AAA, Midget 15, Bantam AAA
- Male AA Model Programs in Midget, Bantam, Peewee
- Female ADM Programs in Midget AAA, Midget Elite, Bantam Elite
- Minor Female Associations

Recommendation of the committee: That 'Streams of Hockey Programs' are not members of Hockey Alberta. Such programs should continue to operate under the authority of a member minor hockey association.

#### Districts / Regions:

The committee noted within the environmental scan that some branches and even some PSO's within Alberta have district models that are much more formal than what Hockey Alberta has. Some have provisions for Districts to be members. Districts, in some cases, were an additional level governance within a certain region and included members grouped together. In other cases they remained members of the Provincial Governing Body. Some Districts had their own Board and, in some cases, were their own society. In at least one case (in a large sport in Alberta) the membership within the association was defined as needing to have a minimum number of participants.

Recommendation of the committee: The committee did not pursue this option as one that fits as a bylaw change. It did not feel that it was a shift that would be currently possible with respect to the minimum size of associations and/or to Districts being an added governance level.

#### **SUMMARY OF OPERATIONAL CONSIDERATIONS**

Simple bylaws are better bylaws. That does not change the fact that whether through regulation or policy that there is work to do to further define how this organization will operate. The following operational considerations are very important moving ahead as well.

<u>Sizes of Associations:</u> It is clear from the information gathered that Hockey Alberta has members of different sizes. While it was determined that all should be eligible to be full members, it is clear that there are different sizes of members as defined within the information. Operationally, it was agreed that Hockey Alberta needs to create a model which services each of these associations in a way suitable to them. While geography has been used for many years, and has some benefits, it is as important to ensure there is a sound strategy to serve the variance in association size.

<u>Recreational (Pond) Hockey</u>: The need to clearly define what the program encompasses and/or does not. To ensure there is clarity on the line that does exist between this form of hockey and minor hockey, which also has levels of play often considered recreational in nature.

<u>Hockey Canada Accredited Schools</u>: With a new National Policy, it is important that this definition is clear within the overall membership of Hockey Alberta.

Minor Hockey Leagues: It is important that the work of the committee and the overall philosophy of Alberta ONE (league alignment) continue and be formalized. This formalization of how leagues exist within Hockey Alberta could be built into future regulation or policy. This is a very important element for the members in Hockey Alberta. Status Quo is not good enough. Hockey Alberta, its members, and the leagues have to be better aligned.

Officials: This is a vital element to ensure that Hockey Alberta Officials continue to have a voice. It is expected that this will continue with the structure changes within Hockey Alberta but also some of the plans to ensure that each community and each league have a RIC. Their roles will continue to provide service but also to ensure the voice of the official is heard locally, by the league and by the provincial body through the committee and the Manager, Officiating.

Streams of Hockey: Further definition and communication with these groups needs to continue. Hosting Male ADM, Female ADM and/or AA programs has to come with strong guidelines for what is and is not expected. While important to have, local guidelines or practices cannot take precedence over provincial guidelines.

#### **VALUE OF MEMBERSHIP**

Through the discussion, the committee felt it is important to recognize what being a member means: What is the value to be part of the membership of Hockey Alberta? As part of this, the committee has worked with management to identify items that are valuable to membership. This is an ongoing element, but it is a very important one for Hockey Alberta and its members to understand.

#### **BYLAW RECOMMENDATION**

After review of the each of the elements, the committee built a bylaw which it believes encompasses all elements.

Recommendation of the committee: That the following proposed bylaw be reviewed by Hockey Alberta members. The finalized bylaw would be brought to a future Hockey Alberta General or Special Meeting after full consultation with the membership.

#### ARTICLE 1 - MEMBERSHIP

#### 2.1 Regular Membership

- (a) Subject to the conditions precedent set out herein and compliance with these Bylaws and the Rules and Regulations, regular membership in Hockey Alberta is open to the following:
  - an Amateur Hockey League of the Junior, Senior, College or University Division, that is not within or a part of a Minor Hockey Association, that satisfies the requirements of the Board from time to time for regular membership and is located and registers players with Hockey Alberta;
  - a Minor Hockey Association that satisfies the requirements of the Board from time to time for regular membership and is located and registers players with Hockey Alberta. provided that Hockey Alberta will only recognize one Minor Hockey Association for each city, town, village or hamlet;
  - (iii) an Accredited School program, that is not within or a part of a Minor Hockey Association, that satisfies the requirements of the Board from time to time for regular membership and is located and registers players with Hockey Alberta;
  - (iv) a Provincial or Regional organization that operates an amateur hockey program for Adapted Hockey or Recreational Hockey, that is not within or a part of a Minor Hockey Association, that satisfies the requirements of the Board from time to time for regular membership and is located and registers players with Hockey Alberta.

#### **VOTING**

The committee agreed that the current model is not adequate. The committee determined that the best opportunity for a new model would rely on using "player registration" to properly weight any new voting protocol. The Committee felt that each member needed to have a minimum of one vote. The committee did not feel weighting should be 1 vote per player. The committee looked at models which featured weighted voting for every 50, 75, 100, 250, 500, 1000. The committee also reviewed the current voting model for Hockey Alberta as a comparison. More data and information on the current model, and a version based on100 players per vote is attached for reference. A secondary bylaw would need to be amended to address voting.

Recommendation of the committee: That the best model moving forward would be to use the 1 vote per 100 participants.
