2. 100 tickets were printed.
3. Tickets to be sold for \$100 per ticket.
4. Tickets can be purchased by cash, cheque or credit card – either in person, by mail or phone to the Hockey Alberta office at 403.342.6777 or Room 2606, 100 College Blvd, Red Deer, Alberta, T4N 5H5.
5. First day of ticket sales will be February 16, 2017.
6. Final day of ticket sales will be noon March 22, 2017, until all 100 tickets are sold.
7. Draws will take place at 2pm MST on March 23, 2017 at the Hockey Alberta Office – Room 2606, 100 College Blvd, Red Deer, Alberta T4N 5H5.
8. Must be 18 years of age to purchase raffle ticket.
9. Contact name listed must be a purchase 18 years of age or older.
10. Any team or individual in the province of Alberta is eligible to purchase a ticket including Hockey Alberta employees and immediate family. The Executive Director, (Tim Leer) and Manager, Marketing and Events (Danielle Kraichy) are not eligible to participate.
11. A minimum of 10 tickets must be sold for raffle to proceed.
12. A total of two draws will take place. The single ticket of the winner of the first draw will not be reentered into the second draw.
13. No cash alternatives to the prizes.
